

### MATERIAL HANDLING OVERVIEW

- Most venues and trade shows have rules regarding the handling of freight and materials. It is important to be familiar with the Las Vegas Convention Center (LVCC) and ASD guidelines for a safe, smooth and successful show.
- At LVCC (and similar convention centers), safety is a priority. Freight
  is not allowed through non-freight doors, including front doors.
  Using carts, dollies, or other equipment through these doors is a
  potential safety hazard to individuals, and causes excessive wear
  and damage to building doors, glass, frames, thresholds, and
  lobbies.

IMPORTANT: While in the past the building has been lenient with some of the rules regarding freight in and out of the building, going forward this will no longer be the case. Please plan accordingly.







### WHAT IS MATERIAL HANDLING?

- Material handling is the movement of items from freight doors and docks, to your booth, and back to freight doors and docks.
- At ASD, Freeman (utilizing union labor) is the exclusive provider of material handling services, which include:
  - Storing your freight up to 30 days in advance at the warehouse
  - Delivering freight to your booth
  - Handling of empty containers to and from storage
  - Removing of material from the booth for reloading onto outbound carriers



Material Handling is <u>THE</u> way you bring your merchandise & product for your booth into the Building





### HAND CARRY VS. FREIGHT

### **Hand Carry**

- Hand Carry is defined as:
  - Anything that can be hand carried by <u>one</u>
     person in <u>one</u> trip without the use of carts,
     dollies, and other material handling
     equipment.
  - Hand Carry exceptions can include:
    - Use of a small, lightweight luggage cart
    - Use of lightweight garment racks that have garments hanging from the rack (NO boxes or containers loaded on the base)
- Hand carry is allowed through non-freight doors.


### **Freight**

- **Freight** is defined as:
  - Anything that requires the use of carts, dollies, and other material handling equipment
  - Anything that takes more than one person one trip to hand carry without the use of carts, dollies and other material handling equipment
  - Anything more than approximately 300 lbs.
- Freight must be brought in through freight doors utilizing union-managed material handling services.





## **TYPES OF ITEMS PERMITTED** THRU NON-FREIGHT DOORS (HAND CARRY)

garments hanging only





### FREIGHT AND DELIVERY OPTIONS

### **#1: Ship Your Freight:**

Ship to the Advance Warehouse between February 17 and March 11, 2026. This convenient option ensures your freight is waiting for you at your booth upon arrival. It's the best choice!

**Ship to Show Site.** Your carrier checks in at the off-site marshalling yard before being dispatched to the convention center for unloading and delivery to your booth.

Your complimentary material handling allotment applies to Advance Warehouse and Show Site shipments!

### **#2: Drive Your Own Freight:**

Follow the "Freeman POV" signs on Joe W
Brown Drive to the loading docks. Look for
the Cartload Service signs for your
designated hall (Central or North). Map
here.

### **#3: Hand Carry Small Items:**

When hand carrying from your personal vehicle, proceed to the closest parking lot and hand carry your item in.

Parking will be extremely limited and is not guaranteed


**Curbside parking**

### FAQ'S



### 1. Why can't I bring in my cart or dolly through non-freight/front doors?


- At LVCC and most similar convention centers, freight is not allowed in through non-freight doors, including the front doors. Bringing in freight on carts, dollies, and other material handling equipment through non-freight doors is potentially unsafe and results in excessive wear-and-tear and damage to doors, glass, frames, thresholds, and lobby areas.
- Bringing in heavy loads on escalators and non-freight elevators can cause them to break down and become unsafe to use and/or operate.
- Please reference slides 6-8 for examples of what is permitted and not permitted.

### 2. What are my options if I can't use my cart or dolly and I have too much freight to hand carry?

- There are multiple convenient options to handle your freight (reference slide 10):
  - If you use shipping services: Ship to the Freeman Advance Warehouse between February 12th and March 11th. (best option) or ship directly to show site where your carrier will check in at the offsite marshalling yard.
  - If you are driving in your own freight: Follow the "Freeman POV" signs on Joe W Brown Drive to the loading docks. Look for the Cartload Service signs for your designated hall (Central or North). Map <a href="https://example.com/here/beta/40/">here</a>.
- Remember, with every 10x10 booth, you have complimentary access to 300 lbs of material handling services provided by Freeman. Take advantage of these savings!







### 3. Why can't I drive my vehicle directly to a freight door and unload myself?

- Safety is always a priority.
- When staging at a top-tier, internationally recognized convention center such as the LVCC, the union has jurisdiction over the freight doors and must manage anything coming in or out of them to maintain best safety practices.
- Union-managed freight operations (i.e. management, labor, safety, forklift traffic, carrier traffic/access, furnishings deliveries, etc.) are essential to a safe and efficient trade show execution.

## 4. Do you have examples of what is and is not allowed through the front doors?

• Small cartons and packages that one person can hand carry are allowed. Small lightweight carts (such as a luggage cart or a garment rack for our clothing exhibitors) can be used to assist. See the images in the previous slides for some examples. This is not an all-inclusive list. Reference slides 6-8.
